School Family Levy

PARENTS PLEASE NOTE:

- Families paying 'Lump Sum' (*Option 1*) receive a \$50.00 discount off the total of the Family, Curriculum and Technology Levy (already discounted below) & must be paid in full by Friday, 1st March 2024.
- We are recommending all families not paying in lump sum to set up a direct debit payment (*Option 2*) via bank account as this helps families manage their financial commitments but also reduce the administrative burden to our office. To assist us with the setup for this process, we are asking families to elect their payment details on the Direct Debit Authority Form and return to the office by Friday, 8th December 2023.
- Other available payment options (3 and 4) are listed below. **Families are expected to choose an option by Friday, 8th of December 2023.**
- The Technology Levy contributes to the school's commitment to provide the best, most up-to-date technological equipment for our students. This Levy will purchase Laptops, iPads, Wi-Fi components, upgraded servers and software for use by students and school staff.
- Camp Fees (Yr. 4/5/6) & Swimming Fees (Preps only) need to be paid within 30 days of when billing occurs.

Note: Amounts exclude any camp charges

The following families are encouraged to apply for concessional school fees:

- Any family holding a Health Care Card and eligible for Camps, Sports, and Excursions (CSEF).
- Any family of Aboriginal or Torres Strait Islander Heritage.
- Any family experiencing severe financial hardship.
- Any family holding a DVA Gold Card.
- Any family identified as refugees and holding an ImmiCard.

Families must agree to a direct debit arrangement to qualify for the concessional fee policy.

Families who meet one of the above criteria will be required to fill out forms in February 2024.
